Your course is subsidised by the Education and Skills Funding Agency (ESFA). Cambridgeshire County Council Adult Learning and Skills administer this for the Centre that you are learning with and as such all delivery is subject to the ESFA Funding Rules. Your Centre may have their own set of terms and conditions. Where there is a conflict, those below take precedence.

#### **Enrolment**

You will not be admitted to class unless you have enrolled and paid the appropriate fee where applicable The information required may vary according to the learning taking place. If in doubt, provide more detail. The data will only be used (as explained below) where appropriate. Contact details should be provided to allow your course tutor or provider to contact you.

#### **Examinations**

If you withdraw from a course or do not complete course work or other requirements for any examinations or external assessments for which you were granted a free entry, you will be required to reimburse the full fees. In the event of ill health a doctor's certificate will be required. If you pay for your examination and withdraw or do not attend for 6 weeks prior to the examination, you will not be allowed into the examination unless a doctor certifies the absence.

#### Concessions

## **How We Use Your Personal Information**

This privacy notice is issued by the Education and Skills Funding Agency (ESFA), on behalf of the Secretary of State for the Department of Education (DfE). It is to inform learners how their personal information will be used by the DfE, the ESFA (an executive agency of the DfE) and any successor bodies to these organisations. For the purposes of the Data Protection Act 1998, the DfE is the data controller for personal data processed by the ESFA.
